## <u>ORDER</u>

1. The Complainants are the allottees in the project 'PETRONEST' developed by the Respondents. The relief sought by the Complainant in 281/21 is for the car parking allotment as per the sale deed and relief sought by the Complainant in C No. 310/21 is for handing over of all relevant documents in connection with the construction of entire apartments including copy of the original plan for tower No. 1. The Respondents filed written statement in both the cases.



2. Heard both parties in detail. In the last hearing, the Complainant in C No. 281/21 submitted that the matter is settled and he submitted a memo of settlement/ Consent terms signed by both the parties which is marked as **Exhibit A1**. The counsel for the Respondent submitted that the documents asked by the Complainant in C No. 310/21 have been handed over, which was admitted by the Complainant also.

Hence both the Complaints are hereby dismissed.
