ORDER

 The Kerala Real Estate Regulatory Authority issued project registration to the real estate project 'Confident Lotus' promoted by 'M/s. Confident Projects Residential' as per the certificate No. K-RERA/PRJ/016/2020 dated 24.02.2020 under section 5 of the Real Estate (Regulation and Development) Act, 2016. The registration expired on 25.01.2022 and it was further extended up to 25.01.2023 as per the general orders K-RERA/T3/102/2020 dated 15.05.2020 and 19.07.2021 issued by the Authority, invoking the provisions of section 6 of the Act in connection with the Covid pandemic.

- 2. Now the promoter filed the formal application for the extension of registration of the real estate project for six months in Form No. E. As per the proviso to section 6 of the Act, 2016, the Authority may in reasonable circumstances, without default on the part of the promoter, based on the facts of each case, and for reasons to be recorded in writing extend the registration granted to the project for such time as it considers necessary, which shall, in aggregate, not exceed a period of one year.
- 3. The promoter has filed a detailed affidavit showing the present status of each item of work completed and balance of work and other allotment details. The project is in the final stage and finishing works has to be completed. The promoter agreed to complete the finishing works of the project within the requested period of six months. In the project, 69 units are sold out of 130 units. The allottees have formed an adhoc committee. The applicant has remitted Rs. 2,48,339/- (Rupces Two Lakh Forty-Eight Thousand Three Hundred and Thirty-Nine only) as fee for the extension of registration.
- 4. Considering the above facts and circumstances of the case, the Authority in exercise of the powers conferred under section 6 of the Act, 2016 read with rule 8 of the Kerala Real Estate (Regulation and Development) Rules, 2018, decided to extend the registration of the real estate project 'Confident Lotus K-RERA/PRJ/016/2020', for six months from 26.01.2023 to 25.07.2023 with the following conditions.
 - The extended period shall not affect on any of the rights of the existing allottees as envisaged in the Act, 2016.
 - ii. The 'Association of allottees' shall be formed and incorporated as per the laws.
 - iii. The promoter shall complete the project in all respects within the extended period.

- iv. The occupancy certificate shall be obtained within the extended period and shall upload the same in the web portal of K-RERA.
- v. The promoter shall also transfer / hand over the common area and documents pertaining to the project to the Association of allottees, after the completion of the project as promised to the allottees.
- vi. After the completion of the project as promised to the allottees and transfers
 / handing over the common amenities to the Association of allottes, Form No.
 6 shall be uploaded by the promoter in the web portal of K-RERA.
