A special wing of the authority is monitoring advertisements on conventional media and social media platforms to identify unregistered projects. Defaulters are asked to take registration and pay a fine for skipping the rule.

K-RERA clarifies on 'Real Estate Projects'

The Kerala Real Estate Regulatory Authority (K-RERA) has sought to bring

more clarity to the definition of 'real estate project', as it would apply under the Real Estate (Regulation



and Development) Act, 2016. The authority issued orders stating that if the land under development exceeds 500 sq m in area, it will be considered a real estate project even if the number of units - apartments, plots and villas – are fewer than eight in number. It will also be considered a real estate project even if the land in question is below 500 sq m, but the number of units exceeds eight.

The registration of Real estate project is mandatory in the planning area, where the area of land proposed to be developed as plots is more than 500 sq.m. The promoters should obtain development permit prior to the registration process with RERA, irrespective of the number of plots.

The secretaries of the LSG Institutions should utilize their power to issue stop memo when they notice the constructions or developments which violates the regulations. In addition, such violations may be intimated to the Authority. The Authority has already issued order regarding this.

According to the RERA Act 2016, K-

RERA has the power to levy penalty upto 10 percentage of the project cost if a promoter advertise or sell his project without registering RERA. He reminded that the legal security for the buyers can only be assured in case any dispute arise in the future if the plot or villa or flat is purchased from RERA Registered projects. Therefore it Is necessary for the Panchayats, Municipalities and Corporations to join hands with K-RERA in order to make the peoples' lives easy.

The Chairman gave awareness about the Real Es------ tate (Regulation and Development) Act in the session. The Members of the authority Adv. Preetha P Menon and M.P. The advertisement of Simple group of Companies was placed infront of the entry gate. Red Porch Nest tried to grab attention of the consumers through facebook and via brochures. Fracisco Builders used their website and social media for advertising.
