1. The Kerala State Housing Board, applied for the registration of the project '**KSHB HIBISCUS**' located at Padamughal Road, Vazhakkala in Eranakulam District under Section 3 of the Real Estate (Regulation and Development) Act, 2016 before this Authority. The Authority granted registration to the project on 08.06.2023 vide reference number **K-RERA/PRJ/ERN/100/2023**, under Section 5 of the Act,2016. The registration of the project expired on 15.04.2025.

2. After the expiry of the registration, the promoter submitted a request dated 16.04.2025 for deregistration of the project, along with an affidavit as required. The promoter affirmed that the present status of the project is 0% and that no development or construction work has commenced. The promoter has now decided to discontinue the project. It was further affirmed that none of the 6 apartments and 2 commercial units in the project have been sold, and no amount has been collected from any buyer or allottee. Additionally, no agreement for sale has been executed with any person or entity in relation to any unit in the said project.
3. On the basis of the request and the affidavit filed by the promoter, the Authority hereby decides to allow the cancellation of the project '**KSHB HIBISCUS**', which was registered before the Authority vide reference No. **K-RERA/PRJ/ERN/100/2023** dated 08.06.2023
4. Accordingly, the webpage of the project in the portal of the Authority shall be indicated as Abandoned / De- Registered project. The promoter is also debarred permanently from accessing the webpage of this project.
